

Dear friend,

This report you have before you is different. We are not simply reporting on a year of activity. In this report you will find a summary of our results and our impact on the Strategic Plan that came to an end in 2022. These have been difficult years, not only for the social sector, but also for the world as a whole, which has been affected by a pandemic, a war declared in the global north that has added to the dozens of other conflicts in the world, and a climate crisis that is becoming more and more evident. All of these phenomena are caused by human beings, who have the power to reverse many of the inequalities and injustices that are perpetuated today.

We have increased the magnitude of the results of our projects in Sub-Saharan Africa thanks to agreements with the governments of different countries, the commitment of their civil society and the research initiated. All the steps taken within different sectors, following the guidelines set by the World Health Organisation and the Sustainable Development Goals, are necessary and essential to achieve a well-being that reaches more people and brings a shared prosperity. Some of the phenomena I highlighted at the beginning of this message are still with us today, some of them more obviously and others less so. They are threats to the well-being of everyone and directly affect the right to health of all. Let us always defend it.




Weaving partnerships






BU-LABNET, having a diagnosis is the beginning of healing

Yes, you read that right, we said healing, because it's not just a case of a treatment that cures the ailment itself, it's about healing you from the inside out; removing the uncertainty and anxiety that comes from not knowing what you have. Having an accurate diagnosis is much more than determining the necessary treatment, it's a lifeboat for your mind in the middle of a storm. That's why the Buruli ulcer laboratory network, BU-LABNET, aims to improve the quality of diagnosis in the African region by ensuring that all laboratories in the network use standardised procedures for PCR-based diagnosis of Buruli ulcer.

BU-LABNET currently operates in 12 laboratories in 9 African countries. However, we aim to gradually add other endemic African countries and laboratories to the network.





What we are achieving?

- Providing training and support to laboratories in the region.
- Conducting collaborative research to improve diagnostic approaches to BU.
- Integrating other neglected tropical skin diseases with a cutaneous manifestation (NTD-CMs) into the platform based on a single PCR test.
- Improving knowledge exchange.
- Implementing an External Quality Assurance (EQA) programme for PCR laboratories in the network through a centralised coordination system.
- Improving the quality of data reported by WHO in Africa.





Working as part of a network

Another achievement that should not go unmentioned is the networking carried out, together with several international cooperation organisations in different countries in the north and in collaboration with the ministries of health and national programmes of each participating country, all under the auspices of the WHO. This joint effort to harmonise the work of all laboratories will expand the diagnostic capacity not only for BU, but also for the rest of the NTD-CMs. United, we are stronger.















Making organised civil society in Ghana more aware of the issue of neglected skin diseases

You may have noticed, looking at some of the data on the previous pages, that this year we have approved a slightly higher number of projects than in previous years.

This is because last year we launched a call for proposals for civil society projects in Ghana which had a very good response as we received a large number of high-quality proposals from different Ghanaian organisations.



Community integration and systems strengthening project against skin NTDs

Led by a partnership between Tim Aid Africa Ghana, the Indigenous Women's Empowerment Network and Global Media Foundation, in the Brong Afaro region, which shares a border with neighbouring Côte d'Ivoire. This project addresses social stigma and community rehabilitation through an empowerment and networking approach in four villages in the region.

One cycle ends, another begins: reviewing the ground covered during the 2019 to 2022 strategic plan


In 2022 we have come to the end of a strategic plan in which we have implemented a comprehensive and integrated approach. By integrated, we mean that governments in each country change from having a separate programme for each skin disease to an integrated approach that allows them to diagnose all types of skin disease every time they carry out a diagnostic action in a community. An integrated approach also refers to the fact that, in addition to the disease itself, they also work to improve the physical environment, as well as the social and economic conditions of the affected population.






During the years covered by the strategic plan, 51 projects have been financed with a total of €23,386,866

Mobilised resources – Strategic Plan 2019-2022



The majority of these funds (59%) went directly to support the work of the governments of the 4 countries in which we have been working: Côte d'Ivoire, Ghana, Togo and Benin. Although, as can be seen in the graph, the main recipient of funds in the country projects has been government programmes, while in the regional projects we have mainly supported research institutes.


Investment of own funds by type of local partner and country



In addition to addressing the diagnosis and treatment of neglected tropical diseases, we have implemented an integrated approach that has led us to provide almost 4 million euros to support research related to these diseases. As previously highlighted: better diagnosis means better treatment. We have also worked on issues related to improving the living situation of those affected, as well as on the prevention of risk hotspots. We have carried out work in the fields of water and sanitation, political advocacy and gender, etc., and we have also made our small contribution in emergency situations.

Weconomy, investing with purpose




Every day more and more people are committed to making this world a better place for those who come after us. We know that money moves the world, but we believe that it could be moved in another way. How? By focusing on people and their development, on taking care of our planet and narrowing the inequality gap.

Many organisations that work for social justice, human rights and the sustainability of our planet are committed to this change in model. Just as we take care of the planet by managing waste, or we consume local food that generates sustainable development and local employment, we can also manage our money in a way that makes the world a fairer place. We call it Weconomy – the economy of the common good. It is a path that reinforces our mission of achieving social justice and equality by guaranteeing everyone's Right to Health.

In addition, through this responsible management of our assets, we aim to inspire other organisations to move forward by adopting this change.

How do we manage our assets?

We continue to increase our commitment to investing to achieve the greatest impact, this now accounting for 30% of our asset management with 23 impact funds in our portfolio.

2

In addition, the new funds increase our impact in Africa. We now have 5 funds whose investment is 100% in Africa and a total of 14 investment funds that have an impact on the continent. 4.2M euros working to improve the continent in the agriculture, education and health sectors.

3

Collaboration with 20 foundations. The Impact Foundations Fund now invests in 2 high-impact social enterprises in Spain, creating employment in groups at risk of exclusion with RobinGood and supporting regenerative agriculture and fighting against "emptied Spain" ("la España vaciada") with Apadrina un Olivo.

4

We are part of the main networks and platforms in Spain, Europe and Africa and we get involved in their events, talks and training to publicise our asset management model. This year we have promoted the inclusion of impact investment in the new Spanish Cooperation Law and in the processing of the new Basque Cooperation Law.


Weconomy Impact, our new programme to support social entrepreneurs in Africa is a reality. We support projects that complement our work in traditional cooperation: a research centre, Helix Biogen, which will create a 100% African-manufactured Yaws test, and a solar energy company, Sosai Renewable Energies, which will bring this technology to the most remote communities where NTDs are most present, improving people's quality of life.

Launch of Weconomy Impact, a new way to support impact entrepreneurship for new initiatives in Africa

During 2022, the Weconomy Impact pilot project was launched to promote social entrepreneurship initiatives in Côte d'Ivoire, Nigeria and Ghana, specifically to combat Neglected Tropical Diseases (NTDs) in these areas:

- · Detection, control and elimination of NTDs
- · New healthcare technologies and digitisation
- · Water, Sanitation and Hygiene (WASH)
- · Women's entrepreneurship
- · Reintegration into the labour market of people with disabilities
- · Improvement of mental health
- · Improvement of Universal Health Coverage
- · Socio-economic reintegration

We launched an open call for start-ups and social organisations from the three countries in order to accompany and accelerate them through the programme.

Anesvad launched the incubation programme to provide social entrepreneurs with the necessary tools to strengthen their business model and optimise their impact. The two companies are: Sosai Renewable Energies Company and the Helix Biogen Institute of Nigeria.


The final closing event of the programme, held in Abidjan from 9 to 11 June 2022, was an opportunity to celebrate the lessons learned and achievements of these start-ups. In addition, the companies were able to meet with the local business ecosystem to pitch their projects in order to obtain more financing. The event also served to strengthen our work in the fight against NTDs in the country, and discuss new opportunities for entrepreneurship linked to health in sub-Saharan Africa.

We communicate to drive change

Seventh Anesvad Awards

These recognise organisations that, like us, generate positive change for the health of millions of people



The seventh Anesvad Awards, for the year 2022, were held on 25 May, coinciding with World Africa Day. In this edition, a slight adjustment has been made in terms of the categories, of which there are now three:

- Award for a lifetime of work. Recognition of a person for their professional career in Solidarity and Cooperation in Sub-Saharan Africa, in the promotion and defence of the Right to Health and/or in the fight against Neglected Tropical Diseases (NTDs).
- Award for the organisation with the best track record in development cooperation. Recognition of the work of organisations that, like us, work for the development of the most disadvantaged populations.
- Award for the best project in education for social transformation. For educational initiatives that work for a more just, equitable society and fight for human rights.

Another novelty is that as of this edition, it is an **international call** for nominations, so that organisations from other countries can apply; allowing us to acknowledge a greater diversity of proposals and initiatives and generate networks with them.

The jury was made up of Lucila Rodríguez Alarcón, representing Fundación por Causa, José Segura, representing Casa África, Paul Ortega, representing the Basque Agency for Development Cooperation, Galder Reguera, representing Fundación Athletic Club, Vanessa López, representing Salud por Derecho, and Albert Roca, member of the Advisory Council for NTDs of the Anesvad Foundation, and was chaired by the president of the board of trustees of the Anesvad Foundation, Garbiñe Biurrun.

For the now traditional colloquium, on this occasion we welcomed the Ugandan feminist writer Rosebell Kagumire, who works at the intersection of the media, gender and development. It also included the participation of Pepe Naranjo, journalist and Africanist from the Canary Islands based in Senegal, regular contributor to media such as El País and the magazine Mundo Negro.

Almost half of the women between the ages of 15 and 49 have undergone female circumcision in Guinea Bissau, and in the case of Muslims this figure rises to 95%. In response to this situation, Fatima Djara de Almeida Sani has founded Dunia Musso in the country.

Fatima was born in Guinea Bissau, although much of her professional work has been carried out outside her country. She has never forgotten her roots and has always worked very closely with Guinea Bissau, not only publicising the work on the prevention of female genital mutilation that she carried out in Spain, but also working directly in the country since 2016. Her work focuses on prevention, awareness raising and political advocacy for the eradication of this scourge. It was in 2019 that she founded the organisation Dunia Musso Guinea Bissau, an NGO that works for the Sexual and Reproductive Rights of Guinean women and for the eradication of female genital mutilation in the country.

Aware of the need to work with an anthropologically respectful approach, given the roots of the practice in tradition, which reinforces ethnic and gender identity, WGK has developed a unique methodology based on the generation of knowledge, creation of scientific evidence on health consequences, and cascading to all the target groups.

This organisation has been working since 1989 in the prevention and care of FGM in The Gambia and in the diaspora in Spain with a migrant population.

Their work is based on guaranteeing access to human rights for the local child population (right to health, access to drinking water, to have a dignified life, to food, etc.) using the Convention on the Rights of the Child and the Universal Declaration of Human Rights as work guidelines.

Their activities revolve around the health centre that they have established in the town of Lokitaung in the northern Turkana region along the borders with South Sudan and Ethiopia. They have been working since 2015 on the direct causes of the problem with the construction of health infrastructures and offering medical assistance. The project for which the prize has been awarded consists of guaranteeing health care for children under 6 years of age for the prevention and/or treatment of malnutrition, tropical diseases, infectious diseases and paediatrics in general in the communities of North Turkana, Kenya.

Solidarity activities and campaigns

Tool #Nadiedijofacil ("nobody said it would be easy")

This is a tool that allows organisations to carry out a self-assessment procedure for their educational and communication practices from a perspective of global citizenship and social change. The procedure also offers strategic and operational tools and keys for organisations to make progress towards the construction of transformative proposals.

ONGAWA benefits from the collaboration of Anesvad in this process. The regional networks and coordinators of NGDOs contribute their ability to provide spaces for meeting and reflection to the process, as well as their commitment to the organisational and territorial diversity of the sector. A contribution has also been made by the university research groups that have already participated in the first phase of "Nadie dijo Fácil", as well as their contribution both in the design phases of the research tools and in the analysis.




Report. Labour mobility as an opportunity for global health. An African perspective

The shortage of specialist health personnel constitutes a fundamental obstacle in the fulfilment of the Sustainable Development Goal (SDG) 3 on health, and a determinant of the inequalities that hinder progress towards it. Unfortunately, this objective is still a utopia in regions such as Africa and in areas such as neglected tropical diseases (NTDs). While the European Union has 43 doctors and 99 nursing professionals for every 10,000 inhabitants, this ratio is only 3 and 18, respectively, for sub-Saharan Africa.

The Anesvad Foundation has established a commitment to the forgotten population of sub-Saharan Africa and to combat the neglected diseases that have plagued it for centuries. That commitment includes the need to provide African health systems with the personnel they need to care for their citizens with dignity. If the reform of the immigration model can help fulfil that commitment, we will commit ourselves to it as we have always done.

On 2 December in the BBK Kuna venue in Bilbao, the report "Labour mobility as an opportunity for global health. An African perspective" was presented by our president Garbiñe Biurrun and the director of the foundation's research area porCausa. Together with them, Paul Ortega, director of the Basque Agency for Development Cooperation and Fátima Djara De Almeida Sani, president of the Dunia Musso Association, also participated. Moderated by the journalist, Maitena Salinas, an expert in human rights, they shared their experiences and the keys to understanding migration as an opportunity to improve the expectations of health personnel.



(IN)VISIBLES

Within the framework of World NTD Day in 2022, an awareness and participation project was launched, aimed especially at young people, in which the problem of Forgotten Health was exposed, focusing on those "forgotten people" of the Covid pandemic, in order to ultimately demand guarantees with regard to access to Health.

The (IN)VISIBLES proposal is characterised by building collaborative stories from individual stories, using tools such as photography and short stories. The campaign has a specific page, https://invisibles.anesvad.org/, which invites people to participate, explaining the theme and offering it as a basis for carrying out work with young people, accompanied by a tutorial to develop processes of photographic micro-stories. Finally, it is a transdisciplinary proposal for education for social transformation that combines the cooperative classroom paradigm with other pedagogies focusing on creativity.

In addition, an opportunity is offered to implement the process facilitated by Anesvad and Ventana a la Diversidad ("Window to Diversity") in workshop format. Various training courses for female trainers have also been designed and provided.

Forgotten healthcare report

Also within the framework of World Health Day, the report Sanidad Olvidada: Un problema complejo con graves consecuencias (Forgotten Healthcare: A complex problem with serious consequences), by Dr. María De Los Ángeles Erazo Pesántez, was published.

The COVID-19 pandemic caused disruptions in universal health coverage (UHC), which aims to ensure that all people can access the health services they need, without risk of financial ruin. This has opened a window of opportunity for citizens, especially those belonging to the health field, to understand the meaning of the concept of Forgotten Healthcare, of not being able to have the necessary medicines and vaccines at the right time. In other words, the lack of guarantees of access to health.

The objective of this document was to address the problem of "Forgotten Healthcare", especially the causes, consequences, effects and impact caused by the neglect of multiple sectors in the fight against Neglected Tropical Diseases (NTDs). In particular, the situation of NTDs with a cutaneous manifestation is highlighted, in order to understand why these diseases have been so neglected and how they affect the most vulnerable population on the planet.



Health Network

Anesvad chose 7 April 2022, World Health Day, as a symbolic date to create a joint platform for health. To this end, Anesvad contacted the winners of past editions of the Anesvad Awards and a platform was established by the interested parties, Sanidad por Bandera (Healthcare as our Flag), with the aim of working as a network to raise awareness about the importance of universal healthcare. encouraging those who defend this cause and making it possible for healthcare to become a reality, to make this brand visible, emphasise its importance and defend it. This platform promoted by Anesvad aims to contribute to the construction of a critical, responsible, equitable, sustainable and transformed citizenry which, by raising awareness about the causes of the social inequalities that affect the right to health, can make individual and collective decisions that generate global impacts.

Micro-theatre

This is a short form of theatre for small groups: micro plays of less than 15 minutes are presented for a maximum of 15 spectators, performed on a stage of which the audience are a part, within a room of less than 15 square metres.

The MICROTEATRO is a multifunctional space in the centre of Madrid where there is micro-theatre for children, micro-magic, micro-dance, art exhibitions, training courses and a meeting place for performers, actors, directors and authors.

The collaboration with Anesvad began in 2013, so this year 2022 has been its ninth season. So far, more than 20,000 spectators have enjoyed the plays performed. During the year 2022, the awareness-raising objective has focused on the crossover between the NTDs-Women's Health issues in Sub-Saharan Africa.



Podcast. For the Right to Health

"For the Right to Health" is the new Anesvad Foundation podcast programme where you will find stimulating conversations about global health with a special focus on Sub-Saharan Africa. This is a new adventure we started in 2022, to share our work and reflect on the challenges of global health.

We launched this podcast channel to share the reality of global health with a special focus on people living with NTDs in Sub-Saharan Africa and those working to achieve the 2030 goal of reducing them. Three episodes were produced during 2022 and will be launched during 2023. During these podcasts, we were joined by Planeta Futuro (El País) journalist Alejandra Agudo and the Salud por Derecho foundation.






INFORME DE AUDITORÍA DE CUENTAS ANUALES EMITIDO POR UN AUDITOR INDEPENDIENTE

Al Patronato de Fundación ANESVAD:

Opinión

Hemos auditado las cuentas anuales de Fundación Anesvad (la Fundación), que comprenden el balance a 31 de diciembre de 2022, la cuenta de pérdidas y ganancias, el estado de cambios en el patrimonio neto, el estado de flujos de efectivo y la memoria correspondientes al ejercicio anual terminado en dicha fecha.

En nuestra opinión, las cuentas anuales adjuntas expresan, en todos los aspectos significativos, la imagen fiel del patrimonio y de la situación financiera de la Fundación a 31 de diciembre de 2022, así como de sus resultados y flujos de efectivo correspondientes al ejercicio anual terminado en dicha fecha, de conformidad con el marco normativo de información financiera que resulta de aplicación (que se identifica en la Nota 2 de la memoria) y, en particular, con los principios y criterios contables contenidos en el mismo.

Fundamento de la opinión

Hemos llevado a cabo nuestra auditoría de conformidad con la normativa reguladora de la actividad de auditoría de cuentas vigente en España. Nuestras responsabilidades de acuerdo con dichas normas se describen más adelante en la sección Responsabilidades del auditor en relación con la auditoría de las cuentas anuales de nuestro informe.

Somos independientes de la Fundación de conformidad con los requerimientos de ética, incluidos los de independencia, que son aplicables a nuestra auditoría de las cuentas anuales en España según lo exigido por la normativa reguladora de la actividad de auditoría de cuentas. En este sentido, no hemos prestado servicios distintos a los de la auditoría de cuentas ni han concurrido situaciones o circunstancias que, de acuerdo con lo establecido en la citada normativa reguladora, hayan afectado a la necesaria independencia de modo que se haya visto comprometida.

Consideramos que la evidencia de auditoría que hemos obtenido proporciona una base suficiente y adecuada para nuestra opinión.

Aspectos más relevantes de la auditoría

Los aspectos más relevantes de la auditoría son aquellos que, según nuestro juicio profesional, han sido considerados como los riesgos de incorrección material más significativos en nuestra auditoría de las cuentas anuales del periodo actual. Estos riesgos han sido tratados en el contexto de nuestra auditoría de las cuentas anuales en su conjunto, y en la formación de nuestra opinión sobre éstas, y no expresamos una opinión por separado sobre esos riesgos.

Cumplimiento del destino de las rentas e ingresos

Descripción

Tal y como se presenta en la cuenta de pérdidas y ganancias adjunta, al 31 de diciembre de 2022 la Fundación tiene registrados bajo el epígrafe de "Ingresos de la actividad propia" los ingresos correspondientes a las subvenciones, donaciones y aportaciones recibidas por un importe de 8.515.996 euros y bajo los epígrafes de "Gastos por ayudas - Ayudas monetarias" y otros los gastos incurridos por la Fundación en la realización de los distintos proyectos en los que participa cuyo importe asciende a 8.109.233 euros, tal y como se desglosan en la Nota 21 de la memoria. El devengo de dichos ingresos y gastos constituyen un aspecto clave en el registro de los mismos, así como el destino de las aportaciones a su finalidad, tal y como se establecen en los acuerdos firmados.

Nuestra respuesta

Como parte de nuestro trabajo de auditoría, hemos analizado los procedimientos establecidos por la Fundación para el reconocimiento de los gastos incurridos, así como los ingresos obtenidos. Asimismo, en el marco de dichos procedimientos hemos solicitado la documentación soporte justificativa, incluyendo los acuerdos firmados con los aportantes, focalizándonos en su correcta contabilización y verificando que los mismos han sido aplicados a su finalidad, tal y como se establece en los mencionados acuerdos y en los distintos proyectos llevados a cabo por la Fundación durante el ejercicio terminado a 31 de diciembre de 2022.

Valoración de las inversiones financieras

Descripción

Tal y como se detalla en la Nota 8 de la memoria adjunta, a 31 de diciembre de 2022 la Fundación tiene registrados en el epígrafe "Inversiones financieras", tanto a largo como a corto plazo, principalmente, instrumentos de patrimonio y valores representativos de deuda por importe de 13.250.841 y 41.371.947 euros, respectivamente. La Fundación, al menos al cierre de cada ejercicio, efectúa las correcciones valorativas necesarias siempre que exista evidencia objetiva de que el valor en libros de una inversión no será recuperable, siendo el importe de la corrección valorativa la diferencia entre su valor en libros y el importe recuperable. El elevado riesgo de que algunos de estos instrumentos de patrimonio presenten deterioro, unido a la relevancia de los importes involucrados, nos han hecho considerar la valoración de las inversiones financieras como un aspecto más relevante de nuestra auditoría.

Nuestra respuesta

Como parte de nuestro trabajo de auditoría, hemos analizado la correcta valoración de dichos instrumentos de patrimonio mediante su contrastación con información pública disponible y con informes de valoración de terceros.

Responsabilidad del Patronato en relación con las cuentas anuales

El Patronato son responsables de formular las cuentas anuales adjuntas, de forma que expresen la imagen fiel del patrimonio, de la situación financiera y de los resultados de la Fundación, de conformidad con el marco normativo de información financiera aplicable a la entidad en España, que se identifica en la Nota 2 de la memoria adjunta, y del control interno que consideren necesario para permitir la preparación de cuentas anuales libres de incorrección material, debida a fraude o error.





En la preparación de las cuentas anuales, el Patronato es responsables de la valoración de la capacidad de la Fundación para continuar como empresa en funcionamiento, revelando, según corresponda, las cuestiones relacionadas con la empresa en funcionamiento y utilizando el principio contable de empresa en funcionamiento excepto si los administradores tienen intención de liquidar la Fundación o de cesar sus operaciones, o bien no exista otra alternativa realista.

Responsabilidades del auditor en relación con la auditoría de las cuentas anuales

Nuestros objetivos son obtener una seguridad razonable de que las cuentas anuales en su conjunto están libres de incorrección material, debida a fraude o error, y emitir un informe de auditoría que contiene nuestra opinión.

Seguridad razonable es un alto grado de seguridad, pero no garantiza que una auditoría realizada de conformidad con la normativa reguladora de la actividad de auditoría de cuentas vigente en España siempre detecte una incorrección material cuando existe. Las incorrecciones pueden deberse a fraude o error y se consideran materiales si, individualmente o de forma agregada, puede preverse razonablemente que influyan en las decisiones económicas que los usuarios toman basándose en las cuentas anuales.

Como parte de una auditoría de conformidad con la normativa reguladora de la actividad de auditoría de cuentas vigente en España, aplicamos nuestro juicio profesional y mantenemos una actitud de escepticismo profesional durante toda la auditoría. También:

- Identificamos y valoramos los riesgos de incorrección material en las cuentas anuales, debida a fraude o error, diseñamos y aplicamos procedimientos de auditoría para responder a dichos riesgos y obtenemos evidencia de auditoría suficiente y adecuada para proporcionar una base para nuestra opinión. El riesgo de no detectar una incorrección material debida a fraude es más elevado que en el caso de una incorrección material debida a error, ya que el fraude puede implicar colusión, falsificación, omisiones deliberadas, manifestaciones intencionadamente erróneas, o la elusión del control interno.
- Obtenemos conocimiento del control interno relevante para la auditoría con el fin de diseñar procedimientos de auditoría que sean adecuados en función de las circunstancias, y no con la finalidad de expresar una opinión sobre la eficacia del control interno de la entidad.
- Evaluamos si las políticas contables aplicadas son adecuadas y la razonabilidad de las estimaciones contables y la correspondiente información revelada por los administradores.
- Concluimos sobre si es adecuada la utilización, por los administradores, del principio contable de empresa en funcionamiento y, basándonos en la evidencia de auditoría obtenida, concluimos sobre si existe o no una incertidumbre material relacionada con hechos o con condiciones que pueden generar dudas significativas sobre la capacidad de la Fundación para continuar como empresa en funcionamiento. Si concluimos que existe una incertidumbre material, se requiere que llamemos la atención en nuestro informe de auditoría sobre la correspondiente información revelada en las cuentas anuales o, si dichas revelaciones no son adecuadas, que expresemos una opinión modificada. Nuestras conclusiones se basan en la evidencia de auditoría obtenida hasta la fecha de nuestro informe de auditoría. Sin embargo, los hechos o condiciones futuros pueden ser la causa de que la Fundación deje de ser una empresa en funcionamiento.
- Evaluamos la presentación global, la estructura y el contenido de las cuentas anuales, incluida la información revelada, y si las cuentas anuales representan las transacciones y hechos subyacentes de un modo que logran expresar la imagen fiel.

Nos comunicamos con el Patronato en relación con, entre otras cuestiones, el alcance y el momento de realización de la auditoría planificados y los hallazgos significativos de la auditoría, así como cualquier deficiencia significativa del control interno que identificamos en el transcurso de la auditoría.

Entre los riesgos significativos que han sido objeto de comunicación con el Patronato, determinamos los que han sido de la mayor significatividad en la auditoría de las cuentas anuales del periodo actual y que son, en consecuencia, los riesgos considerados más significativos.

Describimos esos riesgos en nuestro informe de auditoría salvo que las disposiciones legales o reglamentarias prohíban revelar públicamente la cuestión.
